FIT RESERVATION POLICY – CABIN FARE ONLY

APPLICABLE FROM MAY 2024 TO APRIL 2025

A. Reservation

1. Name as passport and Date of birth is require.
2. Cabin are allocated on random basis, not allowed to request cabin number/cabin location/adjoining room.
3. Pregnant above 24 weeks & Infants below 6 months at the time of sailing are not allowed to cruise;
A passenger under 18 years of age must be accompanied in the same cabin by a passenger 18 years or older.
4. Passport MUST have at least 6 months validity from the returning date; passenger is responsible to ensure that all Travel documents & VISA are in order prior to departure.

Booking Mode	Cooling Period
8 days or more prior to departure	72 hours from time of booking
7 days prior to departure	Not applicable

Note:

- (a) Cooling Period – grace period for consideration of bookings without cancellation charges levied.
- (b) Cooling period policy is **NOT** applicable to the following situations: -
 - (i) sailing during special holiday season; (Peak Season)
 - (ii) the existing booking was cancelled previously and has been rebooked or postponed;
 - (iii) bookings prior to promotions during travel fair

B. Payment Schedule

1. Deposit 50% of cabin fare, balance payment is 60 days prior to sailing.
2. Peak Season 100% deposit of total fare.

C. Amendment Policy

Note:

1. No amendment charges shall be levied for upgrading of cabins in the same cruises, difference between original and prevailing rate will be charged.
2. Add passengers in the same cabin, prevailing rates apply.
3. For any split-off and new cabins will be considered as new booking at prevailing rates.
4. Total cabin change of passenger names will be regarded as cancellation.
5. Any amendment request received less than 7 days, consider as 100% cancellation.

D. Cancellation Policy

Cancellation Notice Received Before Departure	Cancellation Charges
101 days & above	RM50 administration charge per person (not applicable for non-refundable promotions)
100 – 61 days *	30% of full cabin fare
60 – 31 days *	50% of full cabin fare
30 – 15 days *	70% of full cabin fare
14 days & below *	100% of full cabin fare
No Show / No Written Notice *	100% of full cabin fare

** On top of cancellation charges being charged by cruise line, customer is liable for an administration charge of RM50 per person for any cancellation made.*

Note:

1. 100% of full cabin fare will be levied as cancellation charges in case of during PEAK seasons such as Christmas, New Year and Chinese New Year.
2. Change of cruise departure dates, change of vessel and down sale of cruise (such as reduction of cruise length) will be regarded as cancellation.
