1. Reservation

- Name as per passport and date of birth are required
- All passports must have a 6 months' validity as at the end of the sailing period; Guests are solely responsible for obtaining and ensuring they have all necessary visas and travel documents prior to the cruise.
- All pregnant guests are required to declare their condition upon booking. If pregnant guests have entered, or will be entering, their 23rd week as of sailing period, they will not be allowed to board the ship to take the cruise.
A physician's fit to Travel note stating that they are in good health, not a high risk pregnancy, and not entering the 23rd week during the cruise duration is required for all pregnant guests. No refund or compensation will be given in the event of cancellation due to pregnancy.
- Single occupancy at 200% of 1st pax cabin fare.
- (GTY) Guaranteed cabin are not allowed to request cabin number/ cabin location/ adjoining Room.

4. Amendment Name Changes

- Amendment of name is considered a cancellation and will subject to cancellation charge as per above table. Minimum 1 (one) original guest must be maintained in a cabin. (minimum 7 working days prior to sailing).
- Name changes are not permitted at any time for code red sailing or any sailing that has been code red.

5. Adding of guest

- We reserve the right to review and give approval for request of adding 3rd and/or 4th guest to a cabin. This is to avoid exceeding the safety limitation of the vessel.
- The addition of guest will be charged based on the prevailing rate and is subject to real time availability. There may be cases where the booking needs to be changed to another cabin/category if the capacity of the cabin/category booked does not allow addition of guests. In such instances the entire booking will need to be re-priced on the prevailing rate.

6. Casino Operations

- For itineraries calling into Japan, the casino will not be operated when the ship is traveling between Japanese ports or is still in Japanese waters due to custom regulation.

7. Infants & Minor Policy

- Infants must be at least 6 months old to sail, except for certain cruises (e.g., transatlantic, transpacific, Hawaii, cruises with 3+ sea days, and select South American/other cruises) where the minimum age is 12 months.
- For sailings that depart a port in Europe, Asia, South America, New Zealand or Australia, guests aged 17 or under must be accompanied by a parent, a legal guardian or authorized person, who is aged 18 and above.
- The above age limit for sailings that depart from a port in the US or Canada is twenty-one (21), and guest's age is established upon first day of sailing.
- Adults traveling with a minor who is not their child or under their legal guardianship must provide the child's valid passport and visa (or a certified birth certificate) along with a notarized letter signed by at least one parent or legal guardian.

- Should the last names of the parent(s)/guardian(s) and minor child(ren) traveling with them differ, the parent/guardian is **required** to present the child's proper travel documentation (valid passport book and visa (if required)) **and** the child's birth certificate. The name of the parent(s) and the child must be linked through bridging legal documentation. **If name verification cannot be achieved because of a lack of required documents, then the child cannot embark the vessel.**

8. Passport & Visa Requirements

- Guests are solely responsible for securing all necessary travel documents, including passports, visas, inoculation certificates, and legal family documents, ensuring they are valid and available before the cruise. These documents are required for boarding and international travel. No refund or compensation will be given to individuals who fail to abide with the required travel documents.

9. Travel Insurance International Plan

- All guests are encouraged to purchase travel insurance at own expenses.

- Check-In will be closed 2 hours prior to the scheduled sailing time. Guests who arrive late will be denied boarding.
